Getting to Know Partners in the LIO

This meeting was the first in-person meeting hosted by the LIO in several years, bringing together around 50 attendees. To help support connection, participants did three quick rounds of networking to share their name, affiliation, and what they were most excited about for the LIO meeting and/or the Puyallup Watershed Symposium.

I. What is the PWR LIO and What is its Role in the Watershed?

Cindy provided an overview of the PWR LIO's role in ecosystem recovery and human well-being within its geographic area (WRIA 10). Cindy recognized the Puyallup River Watershed Council Board as the PWR LIO Executive Committee and introduced the PWR Leadership Team, a group of four individuals representing agencies and local governments within the LIO to help guide priorities and development of convenings. She also noted that the organizations that participate in quarterly meetings, field trips, and events contribute to promoting cross-sector collaboration and expertise across diverse topics within the Puyallup watershed.

Kristen Durance, PWR LIO Coordinator, discussed the LIO's role in supporting the development of the Puyallup Watershed Conservation Land Trust and Puyallup Community Forest. She also described the new Action Plan model, which connects the PWR LIO's Ecosystem Recovery Plan to regional Puget Sound planning efforts, such as the Action Agenda, to strengthen the implementation of local work. Currently, the PWR LIO has developed two Action Plans—one focused on on-site septic systems and the other on healthy shorelines—both of which have received funding to support local projects.

II. Network Mapping

Attendees participated in a network mapping activity, selecting one of three breakout groups: floodplains and estuaries, climate and health, or stormwater. Each group identified key connections related to their topic, including partners they work with in that sector and the roles those individuals or organizations play. This exercise helped highlight the most critical players involved in floodplains and estuaries, climate and health, and stormwater work. After mapping these connections, groups analyzed patterns, identified gaps in information, and discussed roles that were missing or underrepresented.

This information will be synthesized into a reference for use within the watershed to help connect partners, complete and update action plans, and support coordination across organizations.

III. Breakout Discussions

Attendees were invited to rejoin their topical breakout groups (floodplains and estuaries, climate and health, and stormwater) to reflect on and discuss projects, barriers, and opportunities as they relate to their respective topic area. Ideas from the network mapping activity and breakout discussions are being organized to name projects, barriers, opportunities, and connections pertaining to each of the three topics.

IV. Next Meeting

The next quarterly PWR LIO meeting is scheduled for March 4, 2026, from 12pm-2pm.
